Information sheet on data protection

In accordance with Art. 13 of the General Data Protection Regulation (Regulation [EU] 2016/679), the following information must be provided when personal data is collected:

- **With regard to Art. 13 Para. 1 c) – purpose and legal basis – :**

The address data you have provided will be used only for the purposes of the agreement with you (Article 6 Para. 1b) GDPR) and will not be passed on to third parties.

The data you have optionally provided (telephone, email address) will be used to facilitate the process of contacting you for this or future orders. This use is based on your consent (Article 6 Para. 1 a) GDPR). You can revoke your consent at any time. Revocation of consent does not affect the legality of processing based on your consent before revocation. This data is not necessary for the purpose of executing the contractual relationship with you.

- **With regard to Art. 13 Para. 1e) – recipients of personal data – :**

Your contact details will not be passed on to third parties.

- **With regard to Art. 13 Para. 2a) – storage period – :**

This declaration with your address data will be processed as long as documentation of the rights of use is necessary for the above-mentioned publication. It will be destroyed after this purpose no longer exists.

- **With regard to Art. 13 Para. 2b), c) and d) – your rights – :**

You have the following rights vis-à-vis the controller with regard to your personal data:

- Right to information, Art. 15 GDPR
- Right to rectification, Art. 16 GDPR
- Right to rectification and erasure, Art. 17 GDPR
- Right to restriction of processing, Art. 18 GDPR
- Right to object to collection, processing and/or use, Art. 21 GDPR
- Right to data portability, Art. 20 GDPR

- Since the contact details you have optionally provided (telephone number, email address) are processed based on your consent (Article 6 Para. 1a) GDPR), you can always revoke your consent for processing data for the corresponding purpose. The legality of the processing based on your consent remains unaffected until the receipt of your revocation.

You also have the right to lodge a complaint with the data protection supervisory authority (Federal Commissioner for Data Protection and Freedom of Information).

- **With regard to Art. 13 Para. 2e) – provision of data – :**
